Subject: ISSUE OF ESSENTIALITY CERTIFICATE UNDER RULE 44  
OF THE DELHI SCHOOL EDUCATION ACT & RULES- 1973.

Sir,

With reference to your application on the subject noted above, I am directed to convey the permission of the Directorate of Education, Delhi to your society to run the school from class I to XII subject to the following conditions:-

- (1) That the provision of the DSEA, 1973 and the rules framed thereunder shall be observed by the Society.
- (2) That the management of the school will fulfil all the condition laid down under rule 50 and provide all the facilities given in rule 51 of DSEA, 1973
- (3) That the management of the school will get the scheme of management approved from the Department immediately.
- (4) That only qualified and trained teachers will be appointed and prescribed Govt. scales alongwith all allowances will be paid to the teacher and non-teaching staff through crossed cheques.
- (5) That the management of the school will not ask for Grant-in-aid from the Department.
- (6) That the school will not run for the profit of any individual association or group of persons.
- (7) That in case at any time of management of the school is unable to run the school, moveable and non-moveable property of the school will be transferred in the name of the Director of Education, Delhi.
- (8) That the management of the school will apply for grant of recognition of the school under DSEA & Rules, 1973 separately and recognition will not be granted unless statutory provision of Sec.4(i)(a-f) read with Rules 50 & 51 are fulfilled.

- (9) That all the recognised classes shall be run at one place only.
- (10) That the management of the school will obtain land from DDA in the name of the Society for the Senior Secondary School through the Directorate of Education, Delhi.
- (11) That the school is being run under the banner of Seth Sagarmal Bagrodia Charitable Trust, ED-81, Tagore Garden, New Delhi- 110027 and suitable funds will be made available for the construction of suitable building on the land allotted to the Society as declared, as per the specification of the Department within a period of 3 years and adequate and sufficient accommodation @ 12 Sq.ft. shall be provided for classrooms. The normal size of a classroom is 24' X 20'. No other activities other than education shall be run.

If recognition for the proposed school is not sought after fulfilling all the above conditions within the period of three years, this permission to open a new school shall be treated as cancelled.
